### **President**

- 1. **Approval of minutes** from the 10/30/2023 Meeting. Motion made, 1st Jack Molina, 2nd Brian Zukauckas, All in favor.
- 2. Bonding and Liability Insurance
  - a. Bonding \$110 fro \$10,000 coverage or \$140 for \$25,000 annually
  - b. Discussion Bylaws state that Boosters must carry Bonding insurance to protect Booster funds. The account consistently carries \$20,000 so we are considering increasing the coverage to \$25,000. This increase remains within the budget as it stands.
  - c. Motion to approve raising Bonding coverage to the \$25,000 1st Pete Jones, 2nd Brian Zukauckas, All in favor.
  - d. Liability Insurance \$180 for \$1 million in coverage or \$250 for \$2 million in coverage
  - e. Discussion bylaws do not state that we carry liability insurance. The District coverage ordinarily would cover us on campus or with school transportation. With the off campus Signature Event, Launch, at GLSC this season this coverage may benefit the Boosters. Those present prefer to elect the \$2 million in coverage in case it is needed.
  - f. Motion to approve electing the \$2 million in Liability coverage 1st Brian Zukauckas, 2nd Craig Kowatch, All in favor.

### 3. Fundraisers

- a. Spirit Wear sales \$367
- b. 24 Days update \$12,570 has been raised so far with more families still needing to turn in raffle ticket money. After \$200 per team member requirement is met, the total will be \$23,950 raised. Families who have not met the \$200 requirement will be invoiced.

- 4. Signature Event Updates

    - 2. Available parents would be helpful on Thursday and students after school.
    - 3. Team members should expect to be either competing Friday and Saturday or volunteering. Students will arrive by 7:30am.
    - 4. Middle School team members can volunteer Friday and Saturday as well.

- 1. Income items
  - a. Fall Tournament Concessions and 50/50 \$3,484

  - c. Total Launch donations to Boosters so far \$8,422
- 2. Expense items
  - a. Paid \$1,000 State registration fees for qualified teams
  - b. \$5,000 Launch expenses have been paid as the deposit for GLSC
  - c. World's fees have increased to \$1,800 this year to compensate for adding a day to the tournament in order to allow teams to have some "extra time" in their schedule to allow for meals or sightseeing.
